4	The attached slide pack was reviewed during the course of the AGM and contains relevant information from each presenter.
5.	President: Dave
5.1	Thank you for joining our AGM. I really enjoy being on the board, it has been very rewarding seeing how much we have accomplished over the past few years, a big shout out to all board members and sub committee members for all of their hard work and dedication! Good job! I would like to thank Chis Legler and Deb Nelson who will be moving on from the board for a job well done. The strategic plan that Chris led us to develop has been the cornerstone of our decision making process and guides our planning. I would also like to thank Deb for all of her hard work and for putting this AGM presentation together. I would like to acknowledge how hard this board works for the membership, they are very dedicated and it sure shows in how much they accomplish every year.
5.2	Later on in this presentation you will see that we have some positions that require new people to step forward and fill. We are aiming to fill three board positions but also to try something new. We are



	looking to add some shadow positions where you would be working with a current board member and learn the role that they fill in the club over the next year. This would allow you to gain some experience and confidence before making a larger commitment. We will also be looking to fill a few non board positions as well. I encourage you to give it a try and see how rewarding being an involved Black Jack member can be.
6.	Treasurer / Vice President: Jan Luppens
6.1	The asset and revenue summary reports for year ending 2022 were reviewed. The full reports are attached to these meeting minutes.
	It has been a financially strong year for Black Jack with final numbers in the black, with revenues exceeding expenditures by \$68K. This financial position allowed us to avoid adjusting membership fees for inflation this upcoming season.
	Of particular note this year was the creation of \$146K worth of restricted funds for specific purposes. This ensures we have the funds available when needed and also allows us to meet the asset criteria for grants. These restricted funds include: - \$40K for Trail head facilities upgrade - \$40K to rebuild piston bully 2 engine - \$30k operational reserve - only accessible with approval of membership. - \$20K for Tall Timber trail extension - \$10k for trailer purchase - \$6K for snowmobile
6.2	The Ferraro gift card program remains an important fundraiser for us. Black Jack raises more from the Ferraro gift card program than all the other program users combined
6.3	It was moved by Jan Luppens that attached financials for the year ending 30 April 2022 be adopted. Seconded by Dave Gibson. Carried .
7	Skier Development Program (SDP): Helen Clugston
7.1	SDP is a large portfolio with programs for all ages. The opening photo demonstrates the spectrum and collaboration, showing Remi, our local Olympian, with a young athlete.
7.2	George Grey is our new head coach and his contribution is greatly appreciated.
7.3	A SPD committee is in place with advisors, grant writers and support. Thank you for your immense support and commitment.
7.4	Bunnies and JackRabbits - 82 athletes are registered to date with 21 volunteer coaches. Thank you to Karina Farr for her excellent leadership and coordination.
7.5	Track Attack - 17 athletes and three volunteer coaches with head coach and parent support. Supporting these programs takes a community of coaches, parents and athletes
7.6	U14 - 3 athletes, Youth Loppet - 2 athletes, coached by Kris Heale. Youth Loppet is a new program



	this year targeting teenagers who would like to continue skiing without the pressure of racing.
7.7	Racers - 10 athletes - coached by George Grey with support by Dave Wood. We are doing very well as a team with representation on the BC Talent Squad, BC Ski Team and National Ski team. They are able to excel because the club and community create conditions for success.
7.8	School outreach - 508 kids from 6 schools. The program is being coordinated by Fran Cameron.
7.9	Adults - a variety of lessons are available. A Loppet training group may also be formed based on interest.
8.	Racing / Tourism Rossland / Infrastructure: Adele
8.1	 2021 / 2022 Hosted Races: Kootenay Cup / Canada Cup - Dec 11-12 - The Canada Cup was moved at the last minute to Sovereign due to snow conditions. We held the Kootenay Cup very successfully. Black Jack Loppet - Feb 19th, 2022 - Tremendous participation. No entry fee was charged but partipants were encouraged to purchase CCBC 50/50 raffle tickets.
8.2	2022 / 2023 Planned Races: - Kootenay Cup 1&2 - Jan 14-15, 2023 - Black Jack Loppet - March 11, 2023
8.3	Infrastructure: Thank you to the infrastructure team who have been focused on developing the updated layout of the main trail head area including a new lodge. We have invested in a septic plan and are pursuing grants to build the lodge.
8.4	Social media position last year was funded by grant and filled by Karina Farr. She did a great job and will be doing it again this year.
9	Trails & Buildings : Russell Vinegar
9.1	 Highlights from the past year: Built the Little Rock canine trail Aqueduct and adventure trails rebuilt Biathlon cabin upgrades Fall trial crew did great work and helped the trails open early Work party was successful with over 20 people
9.2	An agreement has been made with the Rossland Mountain Biking Society (Fat Bike Group) to coordinate joint use of the land. The agreement and FAQ's can be found at https://www.skiblackjack.ca/fat-biking.
	The Lower Cedar trail is closed to skiers for safety. It will be an out and back for fat bikers and snowshoers, with no southern exit in order to avoid having bikers on the ski trails.
	Bikers will not pay Black Jack day use fees as they are not using our trails, however their society is



	contributing to the cost of plowing the Biathlon parking lot.
	This is a trial year to confirm the arrangement is working successfully for both parties.
9.3	2023 major projects: - Tall Timbers adaptive trail extension - Biathlon area master plan led by Kameron Farr
9.4	The City of Rossland has commissioned a recreation master plan. The draft has been produced for community input. Key points were provided in the BJ newsletter for members to provide feedback in support of Black Jack, particularly around supporting trail network and trail head amenities.
9.5	The Black Jack trail maps were updated this year.
10	Membership / Kiosk Liaison: Kerri Webb
10.1	Kathleen has returned as our Kiosk manager and is supported by Lawrence Wright and Elain Powers.
10.2	Free ski days will occur on Christmas Day Dec 25, 2022 and Family Day, Feb 20, 2023
10.3	We're very happy to have won the CCBC membership contest! We had the highest on Dec 1 as compared to last year.
10.4	957 members are registered as of Dec 1, 2022, ranging in age from 2 to 90 years old.
11.	Maintenance and Grooming: Howard May
11.1	It was a successful year with no major breakdowns of the Piston Bulley groomers. The addition of the renovator to break up very hard snow has proven useful.
11.2	Isaac Fairfield is returning as our paid groomer. Thank you to our volunteer groomers. This year we have hired Peter Plaut to cover Isaac's days off as opposed to relying only on volunteers.
11.3	The City has called if they are west any analysis and an area was a content is trail and
11.0	The City has asked if they can rent our snowmobile and groomer to groom Centennial trail and potentially Wagon Road. They are also considering purchasing their own grooming equipment.
